### FEMA Releases National Resilience Guidance

FEMA recently announced the release of the National Resilience Guidance (NRG), which will help everyone understand and fulfill their critical roles related to increasing national resilience.

To complement the NRG, FEMA created the Resilience Resources Gateway; the gateway provides additional resources, including a resource library and other materials, that can be used to strengthen community and national resilience.

FEMA will host a webinar to provide an overview of the NRG and the available supplemental resilience resources on October 9, 2024, at 12 pm PT.

# FEMA Requests Public Comment on Updated National Discovery Recovery Framework

FEMA is requesting public comments on its National Disaster Recovery Framework, which explains the federal government's roles and responsibilities for organizing and deploying disaster recovery assistance. It also enhances effective collaboration among federal agencies and state, local, territorial governments and Tribal Nations, while informing nongovernmental partners.

The public comment period ends on October 23, 2024.

## FEMA Risk MAP Systems Plans Planned Outage for Infrastructure Improvement

FEMA's Risk Mapping, Assessment and Planning (MAP) program applications will be offline and unavailable for four days from **12 am on Thursday, Oct. 24, through 11:59 pm on Sunday, Oct. 27, 2024**.

FEMA is planning this outage to enhance the system's performance, scalability, and reliability, ensuring better service delivery in the future. Nearly 40 FEMA Risk Mapping, Assessment and Planning (MAP) applications will be unavailable.

During this period, users of these applications and services will be unable to access flood risk data, view historic and effective flood mapping products, access flood maps, submit data to revise existing Flood Insurance Rate Maps (FIRMs), and use key applications with other capabilities.

### **EPA Launches CRAFT Website**

This month, the U.S. Environmental Protection Agency (EPA) launched a new website, the Climate Resilience and Adaptation Funding Toolbox (CRAFT). CRAFT is a user-friendly resource for technical assistance providers working with federal funding applicants and recipients to develop, apply for, and implement climate-resilient investments. The website provides simple, easy-to-understand resources that can help users consider climate adaptation and resilience before, during and after applying for EPA funding opportunities. Attendees from throughout Region 10 and British Columbia networked and collaborated on a number of pertinent floodplain management topics, including permitting and map revisions for river restoration projects, the Columbia River Treaty, resilience initiatives, compliance, mapping, sediment considerations, project and program showcases, the Federal Flood Risk Management Standard, and the CRS Redesign. Nick Zentner, a storied geology professor from Central Washington University, delivered an engaging keynote presentation on the ice age floods. The conference's field trip followed the ice age theme with a visit to the Wallula Gap and a mammoth excavation site.

NORFMA was honored to present the Lifetime Achievement Award to Darryl Hatheway of AECOM, the Outstanding Individual in Floodplain Management award to Dennis Dixon of Pierce County, and the Outstanding Team in Floodplain Management Award to AtkinsRéalis.
