


Figure 1: FEMA brochure, Earthquake Home Hazard Hunt.

Earthquake Awareness: The Next Steps

Thursday, October 21st was the annual Great ShakeOut Earthquake Drill for many communities around the world. We hope you joined the more than 30 million participants worldwide and used it as an opportunity to practice what you would do if an earthquake struck. The basics of Drop, Cover and Hold On could save your life. The ShakeOut is a great way to maintain readiness and make those response actions second instinct. With those skills as a base, you can start taking the next steps to make your home and your community more earthquake ready.

One of the first actions you can do, and that won't cost you anything, is to take a look at your home and identify potential hazards during an earthquake. Identifying items that could fall and injure someone is a great start to making your home safer. Once you've done that, you can take actions to minimize those risks.

Good starter activities include: strap down televisions, computers, and other expensive or hazardous electronics; secure or move heavy picture and mirrors located over beds or other furniture; brace water heaters and make sure that gas models have flexible connections; and know how and when to shut off utilities.

WA Commission on Hispanic Affairs

The Washington State Commission on Hispanic Affairs (CHA) and FEMA are partnering to expand the FEMA Funeral access to Assistance Program for Hispanic/Latinx communities in Washington. This collaboration is an opportunity for FEMA to work with the Commission to engage with, inform, and reach Hispanic/Latinx community members who have lost a loved one to COVID-19.

"The impacts of the COVID-19 pandemic have—and continue to be—devastating," says Vince Maykovich, Acting FEMA Region 10 Administrator. "By partnering with CHA, we want to build relationships with Hispanic/Latinx communities in Washington and raise awareness about how to register and participate in FEMA's Funeral Assistance program."

"We facilitate access to information and resources to the Hispanic/Latinx communities across the state of Washington. This means that we advise, lead, and help make sure that information is delivered in a digestible, culturally relevant way. We hope to aid in raising awareness about this valuable and important program in our community. COVID-19 has disproportionately affected the Hispanic/Latinx community in our state, and we hope this information encourages our community to apply to this program and help ease the financial aspects of placing a loved one to rest," says María Sigüenza, Executive Director of the Washington State Commission on Hispanic Affairs.

If members of your community incurred COVID-19-related funeral, burial, or cremation expenses on or after January 20, 2020, FEMA may be able to help with some of those costs. To apply, call FEMA at 844-684-6333. The helpline is open Monday through Friday, 6 a.m. to 6 p.m. PT. Multilingual services are available.

If you use a relay service, such as video relay service (VRS), captioned telephone service or others, give FEMA the number for that service. Applicants must be a U.S. citizen, non-citizen national, or qualified alien. However, there is no eligibility requirement for the deceased person to have been a U.S. citizen, non-citizen national, or qualified alien. A funeral assistance video describing eligibility is also available on YouTube in English and Spanish, view and share today.

Training Opportunity: L-273 in Idaho

Twin Falls, Idaho | November 15th-18th

The Idaho Department of Water Resources is offering FEMA's L-273 training course: Managing Floodplain Development Through the NFIP.

This course is designed to provide an organized training opportunity for local officials responsible for administering their local floodplain management ordinances. The course will focus on the NFIP, the concepts of sound floodplain management, Flood Insurance Rate Maps and Flood Insurance Studies, ordinance administration, and the relationship between floodplain management and flood insurance. This course will be offered in Twin Falls, Idaho from November $15^{th} - 18^{th}$, followed by a CFM Exam testing opportunity on November 19^{th} .
